To consider, pursuant to an interim order of the British Columbia Supreme Court dated November 26, 2024, and if deemed advisable, to pass, with or without variation, a special resolution, the full text of which is set forth at Schedule C to the accompanying joint management information circular of Eros Resources Corp. ("ERC"), Rockridge Resources Ltd. ("ROCK") and MAS Gold Corp. ("MAS") dated November 26, 2024 (the "Information Circular"), approving an arrangement (the "MAS Arrangement") under Section 288 of the *Business Corporations Act* (British Columbia) ("BCBCA"), the purpose of which is to effect the acquisition by ERC of all of the issued and outstanding common shares in the capital of MAS not already owned by ERC in exchange for common shares of ERC, which forms a part of a larger transaction whereby ERC will also acquire all of the issued and outstanding common shares in the capital of ROCK in accordance with the terms of a plan of arrangement under Section 288 of the BCBCA involving ROCK, ERC and the securityholders of ROCK, in accordance with the terms of a business combination agreement between ERC, ROCK, and MAS dated as of September 30, 2024, as the same may be amended, supplemented or otherwise modified from time to time in accordance with its terms, copies of each of which are available on MAS' profile at www.sedarplus.ca, as more particularly described in the Information Circular.
